from the meeting of the Commission for Banking Supervision (KNB)
held on 5 January 2005

At its meeting on 5 January 2005 the Commission for Banking Supervision issued a permit for the acquisition by **Svenska Handelsbanken AB Joint Stock Company, Branch in Poland** of a banking enterprise from Svenska Handelsbanken (Polska) SA with its registered office in Warsaw.

The Commission for Banking Supervision approved the appointment of:
