**Resolution No 14/98
of the Management Board of Narodowy Bank Polski
of 10 June 1998**

concerning the establishment of an opinion-making and advisory body called the Payment System Council at the Management Board of Narodowy Bank Polski

Uniform text – legal status as at 15 November 2021

Pursuant to Article 7(2)(2) and Article 17(4)(9) of the Act of 29 August 1997 on Narodowy Bank Polski (Journal of Laws of 2020, item 2027 and of 2021, item 1598), it is hereby resolved as follows:

§ 1. An opinion-making and advisory body called the Payment System Council, hereinafter referred to as the Council, is hereby established at the Management Board of Narodowy Bank Polski, hereinafter referred to as the NBP Management Board.

§ 2.1.^{1) 3) 4)} The Council shall consist of:

3. ¹²⁾ The Chairperson of the Council may also invite representatives of other institutions and entities operating within the payment system to the Council meetings, depending on the subject of the meeting, including in particular:

- 1) representatives of ministries or central government offices;
- 2) representatives of entities operating payment systems or payment schemes;
- 3) representatives of non-bank payment service providers;
- 4) representatives of consumer associations;
- 5) representatives of entrepreneur associations.

§ 3. The objective of the Council is to ensure the coordination of activities of Narodowy Bank Polski, the Polish Bank Association, banks and other domestic entities in the scope of the payment system.

§ 4. ¹³⁾ The tasks of the Council comprise:

- 1) defining the strategic directions of payment system development;
- 2) analysing and assessing the Polish payment system and legal regulations pertaining thereto;
- 3) formulating proposals of measures aimed in particular at:
 - a) mitigation of systemic risk in the payment system,
 - b) improvement of payment transactions and increasing their security, effectiveness and availability,
 - c) limitation of financial exclusion,
 - d) promotion of safe innovation in payments;
- 4) undertaking measures with the aim of integrating actions in the scope of the payment system;
- 5) resolving issues indicated by the NBP Management Board.

§ 5. The procedure of the Council's activity is defined in the regulations adopted by it, approved by the NBP Management Board.

§ 6. In matters included on the agenda, the members of the Council may be accompanied by invited experts.

§ 7. The secretarial and organisational service of the Council is provided by the Payment Systems Department of the Head Office of Narodowy Bank Polski.

§ 8. The expenses related to the activity of the Council shall be recognised as costs of Narodowy Bank Polski.

§ 9. The Resolution shall enter into force on 1 July 1998.
